Quotation Notice

Sealed quotation are invited by the under signed from reputed suppliers to supply the "**Larvicidal Oil**" (Temephose 50% EC) as per guideline of NVBDCP for Beldanga Municipality.

The last date of submission of quotation will be 26/06/2019 up to 2:00 p.m. Quotations will be opened at 3:00 p.m. Quotationers may remain present at the time of opening.

Terms and conditions:

1. Product should have approval of NVBDCP (GOI) and TAC (Technical Committee headed by the Additional Director General, Director General of Health Services, Govt. of India)
2. Product must be registered with Central Insecticide Board. (Copy of CIB registration certificate to be submitted along with the quotation)
3. Valid Manufacturing License to be submitted by the manufacturer for the particular product.
4. Shelf life of the product must be 2 years from date of manufacturing.
5. The manufacturers requires to have 'CIB approved source of import' – certificate for the source or the raw material for preparation of the formulation (if the product is not a proprietary product). Valid agreement with the approved source firm & bill / invoice of purchase from the approved source also to be submitted. **In case of proprietary products, proprietary certificate from the manufacturer has to be submitted.**
6. Either manufacturers fulfill the above criteria or their authorised distributors are eligible to participate in the selection process. Production of tender-specified valid authorisation certificate from the manufacturer is necessary for a distributor.
7. Test report and guarantee certificate from the manufacturer to be submitted at the time of supply.
8. The said Larvicidal Oil should be supplied to store room of CBPHCS of Beldanga Municipality and no carriage charge will be admissible.
9. Supply must be completed within seven days from the receipt of the work order.
10. Payment will be made through A/C payee cheque after full satisfaction of the authority.
11. Tax as per Govt. rules will be deducted.
12. Materials will be cancelled if found below quality and not as per specification.
13. Acceptance of lowest quotation is not obligatory and the undersigned reserves the right to accept or reject any/all the quotation/quotations without assigning any reason.
14. After acceptance of quotation, sample must have to be approved by the authority, Beldanga Municipality.
